Pursuant to Section 162 of the State Finance Law
and Sections 215 and 450 of the County Law.

I. WHEREAS, Act 555-2013, as amended by Act 447-2015, authorized a contract with New York State Industries for the Disabled, 155 Washington Avenue, Suite 400, Albany, New York 12210, through SubCon Industries, Inc., for the provision of janitorial services for the Olean Office Facility, the term of which expires December 31, 2015, and

II. WHEREAS, County Department of Public Works is desirous of renewing the aforementioned contract for a term commencing January 1, 2016 and terminating December 31, 2017, and

III. WHEREAS, the New York State Industries for the Disabled, through SubCon Industries, Inc., has agreed to perform the aforementioned janitorial services at a monthly cost of \$14,660.11 not to exceed \$175,921.32 per year, for a total contract amount of \$351,842.64, to be paid on a monthly basis as invoiced, with the option to increase if the minimum wage increases, now, therefore, be it

Pursuant to Chapter 53 of the Laws of New York of 2015
and Section 450 of the County Law.

I. WHEREAS, a joint grant in the amount of \$75,000.00 in Bullet Aid funding has been awarded to Cattaraugus and Allegany Counties for the Southern Tier Regional Drug Task Force from state funds for Crime Prevention and Reduction Strategies Programs allocated to New York State for the 2015-2016 State Fiscal Year, and

II. WHEREAS, Cattaraugus County shall act as lead agency, on behalf of Allegany County, to process costs incurred by both County Sheriff's Offices in the fighting of illegal drug activity, combating drug trafficking and conducting investigations, and in support of efforts related to the Southern Tier Regional Drug Task Force, and

III. WHEREAS, each county shall receive grant funding in the amount of \$37,500.00 to cover costs incurred through the aforementioned purposes, and

IV. WHEREAS, this program is 100% state funded, now, therefore, be it

Pursuant to Public Law 107-56, Department of Homeland Security
Appropriations Act of 2005, Public Law 108-334 and

I. WHEREAS, Act 236-2014 authorized the Chairman to execute grant documents with the New York State Office of Homeland Security for a grant in the amount of \$40,000.00 for the fiscal year 2014 State Homeland Security Program, and

I. WHEREAS, the New York State Office of Indigent Legal Services has announced that it is accepting proposals for a three-year distribution of funds from the Indigent Legal Services Fund (ILSF) for the period June 1, 2014 through May 31, 2017, and

II. WHEREAS, a three-year plan must be submitted to the Office of Indigent Legal Services which demonstrates that the funding provided will be utilized to improve the quality of legal representation under Article 18-B of the County Law, and

III. WHEREAS, Cattaraugus County has been notified that it shall receive an amount of \$80,733.00 per year for three (3) years, for a total three-year grant in the amount of \$242,199.00 for the period June 1, 2014 through May 31, 2017, and

IV. WHEREAS, the application for the aforementioned funding shall reflect the following proposed uses as have been agreed upon by the Public Defender, the Administrator of Assigned Counsel and Legal Assistance of Western New York, with the approval of the County Administrator:

- III. WHEREAS, one component of the plan for the disbursement of such funds includes salary enhancements made payable to the Assistant Public Defenders and the Administrator of Assigned Counsel (AAC), and
- IV. WHEREAS, the criteria established in the Office of Indigent Legal Services Standards and Criteria for the Provision of Mandated Representation effective January 1, 2013, provides that counties must ensure that attorneys and programs providing mandated legal services have and use adequate resources and procedures to receive or provide compensation commensurate with that of opposing counsel and opposing counsel's office, and
- V. WHEREAS, Act 473-2015 authorized a plan for the disbursement of ILSF funds for the purpose of salary enhancements for Assistant Public Defenders and the Administrator of Assigned Counsel, which were made on a quarterly basis, covering services provided October 1, 2015 through September 30, 2018, and
- VI. WHEREAS, the salary enhancements were made in accordance with the aforementioned criteria and provide parity in the assistant attorney salaries between the Public Defender's Office and the District Attorney's Office, and
- VII. WHEREAS, the County will receive the amount of \$80,733.00 per year, for a three (3) year period, for the purpose of improving the availability and quality of indigent legal services, and
- VIII. WHEREAS, the ILSF grant provides for the reimbursement to the County on a quarterly basis, now, therefore, be it
- I. RESOLVED, that in addition to the regular compensation of the Assistant Public Defenders and the Administrator of Assigned Counsel (AAC), the following amounts be disbursed as indicated on the following chart, so long as the employee has been employed for the complete preceding calendar quarter, minus withholding tax, FICA, retirement and other required withholdings therefrom:

**LOCAL LAW NUMBER 10-2015
COUNTY OF CATTARAUGUS, NEW YORK**

Pursuant to Section 10 of the Municipal Home Rule Law, Section 1202-u of the Tax Law and Chapter 563 of the Laws of 2003.

A LOCAL LAW CONTINUING THE CATTARAUGUS COUNTY HOTEL AND MOTEL TAX

BE IT ENACTED by the County Legislature of the County of Cattaraugus as follows:

SECTION 1. Legislative Intent. Local Law 20-2003 (Intro Number 21-2003), as continued by Local Law Number 3-2006 (Intro Number 3-2006), Local Law Number 20-2009 (Intro Number 20-2009) and Local Law Number 9-2012 (Intro Number 11-2012), imposed a tax on facilities providing lodging on an overnight basis and provided for the collection thereof in order to make funds available for tourism and economic development. The aforementioned Local Law should be further continued for an additional period of three (3) years.

SECTION 2. Continuation of Hotel and Motel Tax.
