**Details of Incident:**

After an investigation conducted by members of the Cattaraugus County Sheriff's Office and New York State Police assigned to the Southern Tier Regional Drug Task Force, Investigators executed a search warrant at 309 North 6<sup>th</sup> St. in the City of Olean. As a result of the search Investigators seized Heroin, Marijuana, packaging material, drug paraphernalia and US Currency. The street value of the Heroin seized is estimated to be in excess of \$1000. As a result of the search Joshua M. Small of (22) of Briscoe St. Buffalo NY, was charged with Criminal Possession of a controlled substance in the 3<sup>rd</sup> degree, a class B felony and Justin D. Vreeland (32) of 309 North 6<sup>th</sup> Street, Olean NY, was charged with Criminal Possession of a controlled substance in the 7<sup>th</sup> degree, a class A misdemeanor. The defendants were held in the City of Olean and are awaiting an arraignment in the Olean City Court. Investigators were assisted by the Cattaraugus County sheriff's Office road patrol division and the City of Olean Police Department's road patrol division. More charges are pending the completion of the investigation.
