**Dealer in Secondhand Material Law**

**Date:** 01/24/13

**Location:** County Wide

Starting February 1<sup>st</sup> 2013, the Cattaraugus County Sheriff's Office will start accepting application for licensing the newly adopted county law of Regulating The Transfer of Secondhand Articles. This new county law, which was adopted in July 2012 and amended in December of 2012 specifically deals with businesses that purchase secondhand items directly from the public or from other businesses. All businesses in Cattaraugus County dealing in this type of sales and purchases are now required by law to apply for the Cattaraugus County Dealer in Secondhand Articles License. Businesses, applicants and license holders will now be required to abide by all stipulations of the new law. Businesses located within the City of Olean are exempt from the new law due to an already existing City of Olean ordinance that is similar in nature.
