Information Bulletin: A Primer for Key Stakeholders

Cattaraugus County
Emergency Services has
begun the process of updating
the County's Hazard Mitigation
Plan (HMP). The HMP will
analyze the hazards faced by
the County and its
municipalities, and identify a
strategy for minimizing the
County's vulnerability to these
hazards.

The planning process to update the HMP will be conducted in accordance with the requirements of the Disaster Mitigation Act of 2000 (DMA 2000). At the end of the process, the Federal Emergency Management Agency (FEMA) will review and approve the plan.

Cattaraugus County has selected Tetra Tech, Inc. (Tetra Tech) to guide us through the planning process.

The following information describes the efforts and the roles of stakeholder organizations to ensure the project's success.

What is the objective of this project?

Cattaraugus County and its municipalities, partner agencies, residents, visitors, and business owners face a wide variety of natural and man-made hazards. These hazards threaten lives, damage property, and interrupt operations. By maintaining a current hazard mitigation plan (HMP) and implementing the projects described within it, the County and its stakeholders minimize the likelihood of hazard impacts and reduce their vulnerability to those impacts.

What is the general process to be used by the County to update the HMP?

The County will establish a Planning Partnership consisting of representatives from County, municipal, and stakeholder organizations. While Tetra Tech will conduct the required analysis and modeling and will develop the HMP document, the Planning Partnership will meet to provide input and review the updated risk assessment, mitigation strategy, and HMP document.

Tetra Tech will meet with municipal representatives to collect information and solicit participation in the planning process. The HMP will include a jurisdiction-specific annex for each municipality that participates. This annex will show the jurisdiction's vulnerability to the hazards analyzed, discuss its capabilities to implement hazard mitigation, and identify and prioritize the mitigation actions that the jurisdiction intends to carry out.

How can municipal and stakeholder agencies participate?

Municipal and stakeholder agencies can participate in the planning process by:

- Providing information (and/or access to information) to County and authorized Tetra
 Tech personnel by the requested deadlines
- Attending and actively participating in meetings and workshops to which you are invited
- Acting as spokespersons for the Cattaraugus County HMP Update project, and reaching out to other stakeholders to share and solicit additional information
- Identifying any mitigation projects that you would like to have included in the HMP

A meeting of the Shared Services Panel was called to order at 6:03 p.m. on Thursday, August 15, 2019 at 28 Parkside Drive, Ellicottville, NY 14731.

Mr. Searles opened the meeting by welcoming everyone and thanking them for coming. He wanted to give an update and begin the process of putting together the 2019 Plan to be implemented in the year 2020 with potential reimbursement in 2021.

Mr. Searles received two phone calls over the last two days. The call received yesterday was from the Director of the State Department of State and the call this afternoon was from the Governor's Representative. The representative is telling us is in regards to our plan, there are three levels of review that need to occur. The first level of review has to be approved for content by State Department of State, second level of review has be reviewed for financial accuracy by the Division of Budget and third is the State Controller's Office, which are the ones that will be cutting the check. We are now through the first two of those elements. The State Division for Budget finished their review of our plan and the dollar amount was over \$900,000 in Cattaraugus County in aggregate. Coming from the Division for Budget, there have only been minor modifications to the proposal that was submitted. What Mr. Searles is told is that we are in the first cadre of counties that are this far along in the process. We are one in four county's leading the pack with regard to this. He is expecting paperwork back from the State very soon and we will need to declare /certify back to them, how we want the money from the savings distributed. It is Mr. Searles intent, as he has said all along, that he believes the money should go back to the municipalities that generated the savings in the amount that was generated. Municipalities have been given the

data with their numbers (reimbursement) on it. There will be a minor adjustment to the number, but he would expect to get news on that relatively soon and when that happens, it will be passed on to the consortium.

In earlier conversations with the State, the amount available for savings was going to be half the savings submitted. What he was told today, was the dollar amount submitted is the amount coming back, which is dollar for dollar savings.

Mr. Searles continues to get bounces from emails. He is asking everyone to confirm their email address and also the email addresses of the others contained on the form provided.

We are developing a plan in 2019, to be implemented in 2020. Reimbursement would be *only* for 2020 fiscal year projects:

It has to be a new shared service. It can't be anything that was previously submitted in the plan. If you said you were going to do something in 2017 but didn't do it, you cannot count it again, it cannot be carried forward. If you did it, it was submitted to the State and it is off the table. You can only get reimbursement from the State in the first year of savings associated with the effort. Nothing that is out there or ongoing, it has to be new and it has to involve a minimum of two municipalities working together.

There is a possibility under the program of 2020 to expand membership. What was decided in 2017 was that we don't have everyone represented here with a room full of people now. When you expand membership, it means another vote for the plan. We can include BOCES, school districts, etc., but Seneca Nation of Indians is not eligible to be in this. You can also do fire districts and any other municipal entities too. They all have to be voted in as a member of this Panel and they would have a vote at the Panel Meetings, but Mr. Searles reminded the group how difficult it is to get everyone in one place at one time for a vote.

Plans have to be submitted to the Department of State, not Office of Budget.

The State recommends we look at and segregate items into different categories. Mr. Searles has given everyone a copy of the categories in the packet. What the State is saying is anything we decide to do, we have to pigeonhole it into one of those categories, so that becomes an administrative and logistical type of thing for us. There's definition for each of the items.

This is actually the second meeting of this Panel. The meeting had to be convened in April, so that was actually the first meeting of the Panel. The legislative body has to have 45 days to review the plan, which needs to be by end of year. There are some scheduling items we are looking at. There needs to be three public hearings and two public meeting. A majority of the Panel need to approve the plan for the 2019 submission to the NYS Department of State, which has to be by Jan 15, 2020.

Kelly Reed has taken the opportunity to sift through all of the other plans that have been approved by every other county in the State, and what she found is a listing of some of the types of shared services that were included in other plans.

Mr. Searles explained the spreadsheet included in the handout. If there is an "X" after a particular project, the municipality cannot reapply for those items, even if they didn't do them. If you don't have an "X", it means you are still in the game and can push that in as an item for the 2020 process. A good solid amount of savings that were generated came from individual projects, as in the judge in Persia. Discrete items include the asphalt zipper and the bulk of savings that came in the use of joint purchases with the County DPW. Signs is also a very good one. If you don't have an "X" after signs, you might want to think about that. It's a huge savings.

Mr. Searles thanked the two ladies in the room, Lola Shaw and Kimberly Merrill, for crunching the numbers and providing the backup to be able to justify the savings for us. That is the bulk of what we are able to get back.

Mr. Filock questions the X's on the health insurance. Mr. Searles explained when they put together the plan, there was a bunch of municipalities that said they wanted to join the County and do a cooperative arrangement using the County's health insurance as a vehicle moving forward. What we found out, is there are administrative problems with that. You have to set up your own insurance corporation, fully fund the liability association, and the state insurance laws are so phenomenal that it doesn't allow this to happen easily. It is like a five year process if you are able to jump through the hoops.

Mr. VanDeCar said that would be along the same lines of the justice court between Hinsdale, Humphrey, Ischua and Town of Olean when they talked about merging courts to one court. The issue is the State of New York Law does not allow it. It is a multiple year process that would require the judge to retire and not run for reelection again. Mr. Searles also said it's a multiple year effort to synchronize across multiple courts. It's not that it's not a good idea, but you cannot do it in one year. Almost every consolidation failed except the Town of Persia, and that was because they eliminated a judge.

Chautauqua County has gone to some type of district court arraignment system. Mr. Searles isn't sure what it is but we can get someone from Chautauqua County to talk about it.

Lorrie Fisher inquired if there's a schedule on when a municipality is able to submit something again? Mr. Searles said you can't do it. If you look at all the X's on the spreadsheet, we need something more concise that you are sure you can do in 2020.

Sue Labuhn - Encourages municipalities not to give up and not implement a project because the State is not giving the savings. That's the only caveat is that you won't get any savings directly given by the State, but you certainly will have savings.

Mr. Searles said this isn't necessarily about getting money back. If you are able to get money back, great, but if you are able to save money as a result of doing things more effectively by working with another municipality, that's what you should be doing.

Mr. Searles said he would open the meeting to the room and do a round-robin because as of right now, he doesn't have any projects to submit. The projects come from the municipalities. The two questions being asked are:

- 1) What are you doing now that could be done with another municipality?
- 2) What shared services projects are you interested in exploring in 2020?

Mr. Searles invited County Department Heads and asked them to do the same thing in terms of thinking about projects they might have to suggest.

Mr. VanDeCar - Town of Hinsdale - The consolidation of justice courts can't be included in the plan, but they will pursue it. When they tried last year, NYS Law is written so it will not allow it, so the New York State Legislature has to change the laws for the justice courts.

They did not jump on with the county-wide assessment, but expressed interest so they had an X. The Town has shared highway services for years with Portville, Allegany, West Clarksville, Ischua, Olean, and the County. They aren't checked off on the list so they will probably expand their use of that.

Mr. VanDeCar asked if they buy off County bid, is it reported to the County? Last week the County was striping roads in the Town of Hinsdale and the Town jumped on to have Hinsdale roads done the same as County roads. He didn't realize they could do that.

The Town of Hinsdale also shares the fuel depot with the school district, fire district and the Town of Portville. This might be something other municipalities look into so there aren't so many fuel depots (environmental hazards). Mr. Searles stated that if we are doing this with the school districts, we would have to get them on the Panel. It doesn't have to be every school district included on the Panel.

Lorrie Fisher, Supervisor, Town of Franklinville- Expressed an interest in grant writing.

Ms. Fisher has been doing the HR training for the Village and Town.

Information Services for protection for computers. They should talk to the Village and see if it can be provided to both Town and Village as a shared service.

Web Posting - The Town talked about a new web, but just haven't gotten around to it. They already combined with Village of Franklinville.

Asphalt Zipper...Ms. Fisher needs to know what it is and what it could do for the rest of us. Explanation in short: It will dig up and recycle a small section of asphalt.

Mr. VanDeCar had one more thing. They are interested in the County's old electronic time clocks. Is there any chance there could be a shared service to acquire a clock for the Town. Is there any way of tying into the County payroll software? This would be beneficial to a small town with 6-8 employees.

Lorrie Fisher - What was the electric company that they were talking about last year? MEGA.

Greg Pearl - They are interested in outside services like engineering and HR training, He has three cars. If they are going to be in the area for training, let the towns know so they can piggy back. There was talk at the last meeting in Olean about two or three municipalities hiring an engineer and each municipality would pay each year, and if you use them, you would get charged more.

Annette Parker - Question on tax bills. Why couldn't that be considered a shared service instead of having the Towns pay the County to print the bills. Dan Martonis will check into this.

Bob Kies - Code enforcement - at the end of this year, their code enforcement officer is retiring. He talked with Ellicottville about maybe sharing theirs. Code enforcement officers are far and few between. You can't get anyone to do the job anymore.

Town of Mansfield also has a situation where they are in process of discussing with County DPW about a bridge that was red flagged. They have to do some sort of transfer and go thru negotiations. He doesn't want to bring it up though if it isn't going to happen until 2021.

They do a lot of things based on County bid. They buy sand, asphalt, salt, plus other things on State or County bid. Mr. Searles said when the County puts bids out, we make sure there is a provision in the bid that allows us to share those bids with municipalities. Right now municipalities have the ability to jump on those and are doing that on a regular basis. The problem we face as a County is it requires heavy cooperation with municipalities. We issue the bid, but we have no idea who uses the bid or what quantities they buy.

Kathleen Ellis, Commissioner of Public Works, said municipalities can just track what they are using and send it to DPW. They will generate savings from there.

Mr. Karcher, Supervisor, Town of Farmersville - Municipalities need to make sure they are documenting. He also agrees with Ms. Fisher about grant writing, HR training and web posting and also LED lighting.

Fred Filock - Supervisor, Town of Leon- The Town of Leon would be interested in black topping one of the roads in Leon. It is common knowledge what horses do to blacktop, but he would like to do a pilot program on one particular road if they could get shared services from the County to black top and pave it for them. he doesn't want to spend \$40,000.

They are also interested in the tax bill shared service.

Jeff Goodyear -Supervisor - Town of Ischua - They received quotes to redo all the fixtures in the office and shop which gives greater return. They are changing out all old fixtures and replacing with LED. National Grid is paying half the bill. Their ROI is about 4 ½ years.

Health insurance buy-out agreement. The Town now has an insurance buyout option that gives the employee 50% and the Town keeps 50%. These are two small things, but they are cutting costs.

Frank Puglisi - Town Clerk - Town of Lyndon - Printing of the tax bills - The Town Clerk that collects taxes for the months of Feb and March, pretty much do so for the County. The Town is paying people already to collect the County's portion of the taxes. Can this be figured in as a shared service with the printing? Mr. Martonis will check into this further.

They are in a current agreement with the Town of Franklinville with assessing. If they have a different shared service agreement (Town of Franklinville is going with the County this year but Town of Lyndon is staying with their assessor) there are other towns around going with their assessor. Can this new contract be used as a "new" shared service? Mr. Searles said yes it can be included as long as it isincluded in the plan generated in 2019 and implemented in 2020.

John Walgus - Supervisor, Town of Persia - Their Public Works Department has a problem with diagnostics. If a light comes on in a vehicle, they don't have a diagnostic tool to tell what the problem is, but the County Public Works Department does have this tool and sometimes when Town of Persia calls they can get right in, but other times when the County is too busy, they can't do it for them. Can't this be a shared service with the County instead of having to spend thousands of dollars on the tool.

They applied for LED. The town grant writer was awarded \$50,000 from NYSERDA to swap out all of their light fixtures in all buildings, they have tank-less water heaters, new heating systems with infrared in highway garages.

At one time, they did a feasibility study for upgrades to the building, but there was a problem with grant writing as they didn't have enough matching funds to get the grant.

Mr. Searles spoke about the line item in the County budget that will assist with the local match requirement. Not saying the county can come up with the full amount, but they can assist. Crystal can explain it to him in detail.

Carol Scheibley - Trustee, Deputy Mayor, Village of Gowanda - The Village of Gowanda currently oversees two town's water departments and would like to move forward and include sewer in that. They do the oversight and management.

Bob Barber, Jr. - Highway Superintendent- Town of Otto- He spoke of asphalt prices. They've succumbed to a few companies buying asphalt, hot top, oil seal, chip sealing, etc. If there was an asphalt plant centrally located in the County, the County could buy direct from the Warren refinery, and save lots of money. When the CHIPS money went up, so did the prices. Another thing, the aggregates could be centrally located near a gravel pit. This would cut down the cost per mile or provide a little competition. Same thing with salt, they were paying \$41 per ton but now it's up to \$55-\$56 per ton. If the municipalities could put all their requests in with the County, can we have bulk buying bulk?

Matt McAndrew-Town of Ellicottville Supervisor - There's quite a few shared services the Village and Town do together, as in engineering, code enforcement, grant writing, water maintenance. The Village maintains the Town and they are creating a new district that the Town will take over the water and the Village will take over sewer and they are going to compile the bills so that there is only one postage cost so they will be sharing the postage cost also.

Another of the needs for the Town/Village is IT Services.

Kathy Martin - Supervisor, Town of Allegany- She would like to speak to Mr. Walgus about missing out on grant and funds. Their building is an old historical building and their engineer spoke with someone from Municipal Solutions who submitted a grant to bring the building up to handicapped accessibility code. The entire project is \$230,000 and the grant is requesting almost all of that.

Kimberly Merrill - Secretary to Commissioner of Public Works - Collaboration with all the municipalities with the new Hazard Mitigation Plan.

Homeland Security, Emergency Services and FEMA propose specific funding opportunities. The County worked individually with the Town of New Albion on a couple of acquisition projects that the Town submitted the actual application for funding, but the Team at the County assisted with that on an individual bases on hazard mitigation things.

A number of parts and joint purchase proposals that municipalities purchased from the County using County prices. It can be tracked internally by comparing it with what the marketing cost would be and show the savings for each municipality.

Maintenance of equipment - if a municipality brings a piece of equipment/vehicle in and they look at it, it can be counted, along with leachate hauling. These are potential thoughts. There are some municipalities that take the County leachate, this would be a reverse savings. Kathy Ellis said they are currently doing it, so it wouldn't qualify, but if there's another new municipality starting it, it would be considered a shared service to use.

Mr. Filock wondered if they could bring their equipment to the County for repairs.

Dan Martonis -Director of Real Property Tax Services- Data Collection would apply to municipalities that are partnering in county-wide assessing starting in October. An assessor does not do true data collection, they do updates for new builds, they get building code information and they go out and take a picture of the property. True data collection through the County actually starts with the computer. You use GIS and break out lands, all the different land types, and then go out and drive the entire town and take pictures, do inventory mailings to everyone to show what we have for the data on their property. If you hired a company to do this, you would be

paying them approximately \$20 per parcel. Mr. Martonis will work up the number to see what other people are paying.

Crystal Abers Director- Economic Development, Planning & Tourism- Census, a couple years ago they counted, but municipalities themselves opted not to provide information, so Economic Development did it county-wide, and that's when they did the LUCA, which is a list of addresses and they had to identify if they missed any, and in Cattaraugus County they missed around 3,500 addresses. That was all compiled and sent and we are waiting for information back from the US Census Bureau.

Grant writing, training and assistance provided by Crystal's Department - A lot of the municipalities have come to the trainings, so if they have taken advantage of the services, they've never documented it but it would generate a savings. There's a line item in the budget to help with match on grants. There's criteria to be met and it has to be a grant that provides a benefit or goal in the Comprehensive Plan in the County.

The marketing that Economic Development does for different municipalities for festival events is nothing that costs the municipality, but the service is saving them money.

Training for County Planning Board, but any planning board member is welcome to come. They do not charge for it. The training is for planners that need so many hours per year for land use, SEQR, that type of thing. There are a whole list of different trainings that they offer.

Under Landbank, demo was one of the things they looked at and they would really like to help municipalities thru the zombie property process. There is a process you have to go through, but they have training on that as well.

MEGA - Crystal's office can also help with that. They had consultants in a couple of months ago and invited municipalities. Two municipalities took advantage of them.

Donna Vickman - Said we should be proud of Cattaraugus County. Jack was a presenter at NYSAC for our Shared Services Plan and other Counties molded off us.

John Padlo - Suggestion if they are contemplating the sewer line, to extend all the way to the old Kmart site if there's any way of collaborating to get that going.

Mr. Pearl's thought process is that it has to be more than the Town and Village. They have put together this Gateway Project off Exit 24. Involved was the University, the City, Town, County and State. Exit 24 is a gateway to their community. The first thing you see is six foot reeds and a run-down building. Try to get everyone on the same page and start applying for different grants

Sue Labuhn Legislator, District 5 - Even if you saw a plan on there that you're not getting the savings from the State, the carat from the State was to get us to do something. This quorum created a venue to tap into other's resources. She thanked everyone for taking the time and putting the work and effort into the project.

Naomi Gennings-Emergency Services - The Hazard Mitigation Plan is a shared service, but it's not. Most everyone in the room is part of 2013 Plan and she is reiterating that they need the letters of intention to participate before they can go forward. They've hired a consultant to do most of that work. The Hazard Mitigation Plan ultimately allows us to have federal funding for a lot of the projects we are talking about. The Emergency Services Staff are starting next year, by going to Highway Department Meetings, Clerks and Superintendents Meetings - something they have to do to bring in more funding.

Mr. Searles thanked everyone for being here and stated that we do have another meeting scheduled for August 29, 2019, at 6:00 PM, at 28 Parkside Drive, Ellicottville. By that time you will have notes from the meeting where each of you have talked about projects you would like to do. We will try to identify clusters of things. Some of the services he heard a need for was grantsmanship, highway, expanding joint purchasing of commodities, the Gateway Project, etc. We will try to come up with a cluster of activities. The next meeting we will try to get people of like-minds to work on different projects so we can see what it looks like to put them in our plan. Plans need a minimum of two municipalities. You will receive a project description packet. If you have something, put it down in writing, get it to Jack and we will start easing out the details of what it looks like. He will also need the contact information because he is fearful that he is missing some people that have changed the email address or he has typed it incorrectly because it is bouncing back.

Meeting adjourned at 7:36 PM.

A meeting of the Shared Services Panel was called to order by J. Searles at 6:01 p.m. on Thursday, September 12, 2019 at 28 Parkside Drive, Ellicottville, NY 14731.

Sir .

He thanked everyone for coming and asked for introductions around the room. He explained that today is the last day to put proposals together for the Plan.

The status of the 2018 savings reimbursement is still sitting idle. We are waiting for signatures. It is like pulling teeth trying to get people to sign up for the money they are already owed. All that is needed is a signature. As of today, we have 17 signatures. If officials won't come in and sign, we (Administrator's Office) will do a sweep across the County to get the rest of the needed signatures. Anyone in contact with the mayor or supervisor from their area are asked to let them know that we need their signature if they haven't already signed Appendix C. K. Reed encouraged them to call the Little Valley office first because the Appendix C (signature page) travels from Little Valley to Olean depending on who has made arrangements to sign it.

He announced that there will be some presentations tonight to talk about certain planks of the plan, particularly health insurance, which is one of the items that was brought up in the last round of the Shared Services Plan and there were two issues associated with it: 1) the State Insurance Department under the current legislation requires you to effectively become an insurance agent of an insurance policy and fully fund the liability, or significantly fund the liability of the program. That would fall on the County to become the agent and the money would need to be put into a reserve, which isn't a small amount. The estimate is somewhere just under \$10 million; 2) the

best estimate we have across the State is that it takes a couple of years to set up and approximately five years to fully implement, therefore, it doesn't meet the criteria of the one-year program.

- At 6:13 PM, J. Searles turned the floor over to Human Resources Director J. Carr, who referred to a slide show presentation to further explain why the Shared Services Plan will not be able to include the requested health plan plank. J. Carr was also accompanied by C. Hammer from Premier Consulting Associates, LLC, to assist with any questions. (Slide show attached)
- J. Carr also did a presentation about EAP trainings through Human Resources for compliance. The County is beginning to morph into an on-line product for the different policies and procedures. This on-line product will generate certificates and listings of those who took the trainings. The required trainings are available on-line 24/7, so there's no reason for anyone not to be able to complete them if required. M. Short handed out a pamphlet (Attached) to explain more about the trainings.

The meeting reconvened at 6:27.

- J. Searles referred to the packets with a list of the projects: These packets represent all proposals that were submitted before the meeting:
 - a proposal to establish a water sewer district consolidation between Town and Village of Ellicottville, Town of Mansfield and the Town of Great Valley.
 - Town of Hinsdale would like to piggy-back off the County's all-inclusive copier lease. This covers the toner and other things associated with it.
 - walk-bridge installation over CR #33 in the Town of Ashford with Cattaraugus County
 - guard rail project with the Town of Olean and Cattaraugus County; the Town has five projects they would like to complete.
 - DPW- Purchase off County bids This relationship is between the municipality and the vendor so the County has no idea what municipalities are buying off contract so there needs to be reporting of this at the end of the year so the savings can be calculated
 - Kent Road bridge project This is a unique project between Cattaraugus County and the Town of Mansfield for a bridge that was red-flagged.
 - Human Resource Training Town &Village of Portville, Town of Farmersville, and a few more interested entities
 - the Town of Persia is very interested in doing joint sharing for a dog control officer, but there's only one town interested and it takes two to make a project, if any other entity is interested
 - tax bills there isn't a proposal written up but there has been discussion about the clarification of what the proposal was going to be. The thought was that the County would not charge the municipalities for the printing of the tax bills. This will probably be dropped out of the plan because D. Martonis stated that this can't be a cost shift, it has to be a savings. S. Labuhn asked if there is a Clerk's meeting coming up that maybe this plank can be taken to for clarification
 - the health insurance proposal will be dropped because it can't be accomplished in one year.
 - N. Gennings stated that the Multi-Jurisdictional Local Hazard Mitigation Plan is a proposal that the County is already doing. The County is creating a plan and has hired a consultant. If a municipality were to do a plan themselves, each would have to pay a consultant collectively.
 - data collection D. Martonis said that and the data collection and reassessment will be basically the same concept as the Hazard Mitigation, we are already doing it, so let's put it in writing
 - shared code enforcement between Town of Mansfield and Town of Ellicottville; they have already
 crunched some numbers and found out there are no savings, so this plank would have to include more
 participants in order to realize a savings, otherwise it will be dropped from the Plan

- reassessment D. Martonis said it's the same concept as data collection, the County is already doing it, so they are putting it on paper
- joint equipment purchases with the Town of Persia. They have no equipment in mind for purchase so this plank will be dropped from the Plan
- computer services and shared IT & group IT equipment services P. Davison stated Towns said they were
 interested but have not agreed to buying any particular pieces of equipment for next year. The proposal
 has the New York State pricing attached if anyone is interested
- MEGA & NYMIR Town of Portville is interested in exploring both of these. MEGA will run numbers for us. J. Searles asked J. Carr how to get signed up with NYMIR, she will check with our broker and set up a meeting

New proposals came in during the meeting:

- shared code enforcement Town of Portville and Village of Portville the Village and Town have their own code enforcement and want to merge so they have one position between them for a cost savings
- Town of Portville and Village of Portville are interested in a loader and salt barn which would be an equipment purchase & a building
- Town and Village of Portville and Town of Olean are interested in the joint purchase of a bucket truck
- shared equipment purchases in the Town of Olean and Town of Hinsdale for the purchase of a new, single-drum, 12 ton roller
- C. Abers said she submitted a proposal for grant research and grant writing assistance. Cattaraugus County
 is willing to work with anyone on it but nobody has signed up for it because they need to have a project in
 mind. If they claim it and don't do it, they can't claim it again. J. Searles said maybe they could do a joint
 grant funding with the ultimate goal to purchase new equipment. C. Abers will do research to see if there
 is a grant associated with any purchases
 - D. Blue spoke up with three more projects through DPW:
- diagnostics and maintenance of vehicles, for Cattaraugus County, Towns of Ashford, Lyndon, Persia, and Village of Gowanda
- administrative assistance for disaster recovery Cattaraugus County, Towns of New Albion, Perrysburg, South Valley and Village of Gowanda
- joint purchase of parts through DPW Parts Room Villages of Little Valley and Gowanda. J. Searles stated if the parts were used in the first plan, they can't be included in this plan. K. Merrill said the only parts that were included in the last plan were hydraulic hoses and couplings. These are the only two items that will not be able to be listed in this plan
- J. Searles said if anyone is interested and would like to be included on any of the planks, now would be the time. The next step of the process is trying to roll these different proposals out to make a Plan. The Plan will be pulled together and the required public hearings will be set. Someone from the County may be reaching out to individuals for clarification of certain aspects of their planks. Please, if you receive a call or email, your quick response will be greatly appreciated.



Q14 If your property is in the floodplain, do you have flood insurance?








Q31 Do you own or rent your place of residence?
