Following an investigation into a complaint from the Cattaraugus County Department of Social Services, the suspects were arrested for Offering a False Instrument for Filing in the 1st Degree (E Felony), Grand Larceny in the 4th Degree (E Felony) and Welfare Fraud in the 4th Degree (E Felony). The charges were the result of the suspects fraudulently receiving \$1,495 in food stamps as a result of concealing and failing to report income from the sales of Papparazzi Jewelry.
