I. WHEREAS, the U.S. Department of Justice, United States Marshals Service, Prisoner Operations Division, Intergovernmental Agreements Branch, CG-3, Suite 300, Washington, DC 20530-0001, is desirous of modifying the terms of the Intergovernmental Agreement with the Cattaraugus County Jail, and

II. WHEREAS, the modifications include language pertaining to COVID-19 and other infectious diseases, pregnant or post-partum prisoners, video conferencing, voter registration, body camera information requests, and restrictive housing and suicide prevention, and

III. WHEREAS, the County, contingent upon available space in the Cattaraugus County Jail, shall accept detainees, on behalf of the U.S. Department of Justice, for an amount of \$101.00 per day per detainee, plus Guard/Transportation at the rate of \$37.00 per hour per guard, and

IV. WHEREAS, the U.S. Department of Justice agrees to pay to the County the amount agreed upon, now, therefore, be it

I. RESOLVED, that the Chair of the Legislature be, and hereby is, authorized and directed to execute a contract modification, on behalf of Cattaraugus County, with the U.S. Department of Justice, United States Marshals Service, Prisoner Operations Division, Intergovernmental Agreements Branch, for the housing of federal detainees at the Cattaraugus County Jail, for a term commencing February 1, 2022 to continue in full force and effect until terminated by either party hereto, according to the above-described terms.

**APPROVING AMENDED CONTRACT BETWEEN CATTARAUGUS COUNTY COMMUNITY SERVICES BOARD AND JAMESTOWN PSYCHIATRIC, P.C. FOR DEPARTMENT OF COMMUNITY SERVICES NURSING AND PSYCHIATRIC SERVICES FOR MENTAL HEALTH CLINIC & PROS PROGRAM**

Pursuant to Section 41.13(a)(6) of the Mental Hygiene Law and Section 450 of the County Law.

I. WHEREAS, Act 523-2021 authorized a contract with Jamestown Psychiatric, P.C., 305 East Fairmount Avenue, Lakewood, New York 14750, for the provision of nursing and psychiatric services for the Department of Community Services Mental Health Clinic and PROS Program, the term of which expires December 31, 2022, and

II. WHEREAS, the Cattaraugus County Community Services Board is in need of a second registered nurse to act as Nursing Supervisor to oversee the nursing day-to-day responsibilities in the Clinic, and

III. WHEREAS, in addition to the staff that Jamestown Psychiatric, P.C., is currently providing, Jamestown Psychiatric, P.C. shall provide a second registered nurse to act as Nursing Supervisor to oversee the nursing day-to-day responsibilities in the Clinic for an amount of \$74,888.00, for a total contract amount not to exceed \$825,377.00, to be paid on a monthly basis, as invoiced, and

IV. WHEREAS, the costs of these services are provided through a combination of state aid, billable insurance, and County funds, and

V. WHEREAS, sufficient funds are included in the budget to cover the cost of the aforementioned services, now, therefore, be it

I. RESOLVED, that the Chair of the Legislature be, and hereby is, authorized and directed to execute an amended contract, between the Cattaraugus County Community Services Board and Jamestown Psychiatric, P.C., to signify the County’s approval, for the provision of the above-described services, for a term commencing January 1, 2022 and terminating December 31, 2022, according to the above-described terms, and be it further

II. RESOLVED, that upon termination of either state or federal funding for this program, then this program shall be automatically abolished, and be it further

III. RESOLVED, that such contract shall provide that upon the reduction of any such funding, the County, in its sole discretion, may terminate the contract on thirty (30) days’ written notice, and be it further

IV. RESOLVED, that in the event of any such reduction, the department head involved shall immediately report such occurrence to the Chairman of the Committee to which the department is assigned, who shall add the matter to the agenda of the Committee's next meeting.

I. WHEREAS, Act 42-2021 authorized approval of a contract with Cattaraugus Rehabilitation Center, Inc. d/b/a Intandem and NYSARC, Inc., Cattaraugus Niagara Counties Chapter d/b/a Intandem, 1439 Buffalo Street, Olean, New York 14760, for the provision of adult day care services and comprehensive programs and service facilities for the mentally ill, developmentally disabled, and physically handicapped residents of Cattaraugus County, the term of which expired December 31, 2021, and

II. WHEREAS, the Department of Community Services is desirous of continuing the provision of the aforementioned services, and

III. WHEREAS, Cattaraugus Rehabilitation Center, Inc. d/b/a Intandem and NYSARC, Inc., Cattaraugus Niagara Counties Chapter d/b/a Intandem can provide comprehensive programs and services for the mentally ill, developmentally disabled and physically handicapped individuals for an amount not to exceed \$265,551.00, to be paid as invoiced, and

IV. WHEREAS, New York State has approved funding for the above-described programs in the total amount not to exceed \$265,551.00 for the period January 1, 2022 through December 31, 2022, and

V. WHEREAS, these programs are 100% state funded, now, therefore, be it

I. RESOLVED, that the Chair of the Legislature be, and hereby is, authorized and directed to execute a contract, between the Cattaraugus County Community Services Board with Cattaraugus Rehabilitation Center, Inc. d/b/a Intandem and NYSARC, Inc., Cattaraugus Niagara Counties Chapter d/b/a Intandem, to signify the County's approval, for the provision of the above-described services, for a term commencing January 1, 2022 and terminating December 31, 2022, according to the above-described terms, and be it further

II. RESOLVED, that the Chair of the Legislature be, and hereby is, further authorized and directed to execute contract amendments, upon notification of award, for the allocation of additional state aid funding or cost of living adjustments (COLAs) or reduction in funding for this program, and be it further

III. RESOLVED, that upon termination of either state or federal funding for this program, then this program shall be automatically abolished, and be it further

IV. RESOLVED, that such contract shall provide that upon the reduction of any such funding, the County, in its sole discretion, may terminate the contract on thirty (30) days' written notice, and be it further

V. RESOLVED, that upon reduction of either state or federal funding for this program, the County, in its sole discretion, and upon notice, may reduce the rate for services provided by the percentage of reduction in state or federal funding, and be it further

VI. RESOLVED, that in the event of any such reduction, the department head involved shall immediately report such occurrence to the Chairman of the Committee to which the department is assigned, who shall add the matter to the agenda of the Committee's next meeting.
