Pursuant to Section 450 of the County Law.

- I. WHEREAS, the Department of Public Works is in need of engineering consultant services for the 2024 Bridge Painting Program-Design Services, for the following structures:
  - Freedom Bridge No. 2, located on County Road No. 21 (Delevan-Elton Road) over Tributary of Elton Creek;
  - Napoli Bridge No. 4, located on County Road No. 7 (Pigeon Valley Road) over Peaslee Hollow branch of Elm Creek;
- Mansfield Bridge No. 12, located on *County Road No. 15* (Dublin Road) over Dublin Creek, and
   II. WHEREAS, Greenman-Pedersen, Inc., 403 Main Street, Suite 330, Buffalo, New York
   14203, can provide the aforementioned engineering consultant services for an amount not to exceed
   \$44,000.00, to be paid periodically on a percent-of-completion basis as determined by the Department of Public Works, and
- III. WHEREAS, sufficient funds are included in the budget to cover the costs of the aforementioned engineering consultant services for the 2024 Bridge Painting Program, now, therefore, be it
- I. RESOLVED, that the Chair of the Legislature be, and hereby is, authorized and directed to execute a contract, on behalf of Cattaraugus County, with Greenman-Pedersen, Inc., for the provision of the above-described engineering consultant services, for a term commencing June 14, 2023 and terminating April 30, 2024, according to the above-described terms.
