I. WHEREAS, Act 203-2015, as extended by Act 454-2022, authorized the five-year lease of a 2009 Ford F450 (Diesel) Super Duty cab & chassis, a 2009 Morgan aluminum van body, and a 2009 liftgate, through Ryder Truck Rental, Inc., d/b/a Ryder Transportation Services, 3247 New York Lakes-194, Buffalo, New York, the term of which expires November 30, 2023, and

II. WHEREAS, the Department of Nursing Homes is desirous of replacing the aforementioned laundry truck, and

III. WHEREAS, Ryder System, Inc., 11690 NW 105<sup>th</sup> Street, Miami, Florida 33178, shall lease a 2024 SAM 20 – Generic GMC cab & chassis, a 2024 Morgan aluminum van body, Model No. GVSD85-16, and a 2024 Palfinger ILK-22 60x94 aluminum liftgate to the Department of Nursing Homes, under the same terms and conditions, for an amount of \$3,353.30 per month plus \$0.09 per mile, for sixty (60) months from delivery date, and

IV. WHEREAS, sufficient funds are included in the budget to cover the cost of the aforementioned lease, now, therefore, be it

I. RESOLVED, that the Chair of the Legislature be, and hereby is, authorized and directed to execute a five (5) year lease, on behalf of Cattaraugus County, with Ryder System, Inc., through Ryder Truck Rental, Inc., d/b/a Ryder Transportation Services, for the provision of the above-described laundry truck, for a term commencing upon delivery of the truck to the Department of Nursing Homes and continuing for a term of sixty (60) months from delivery date, according to the above-described terms.

## AUTHORIZING THE CHAIR TO EXECUTE CONTRACT WITH NEW YORK STATE DIVISION OF CRIMINAL JUSTICE SERVICES FOR ALTERNATIVES TO INCARCERATION PROGRAM (Probation Department – Contract C523915)

# Pursuant to Article 13-A of the Executive Law and Section 450 of the County Law.

I. WHEREAS, Act 130-2022 authorized a contract with the New York State Division of Probation and Correctional Alternatives for an Alternatives to Incarceration Program for the 2022-2023 program year, the term of which expires June 30, 2023, and

II. WHEREAS, the County Probation Department is eligible to receive a grant for the Article 13-A Classification/Alternatives to Incarceration Program, which consists of a pre-trial release component with a total program cost of \$33,702.00, with an amount of \$10,308.00 being funded through the New York State Office of Probation and Correctional Alternatives for the contract term of July 1, 2023 through June 30, 2024, and

III. WHEREAS, the Pre-Trial Release Program provides for the screening and, for those eligible, background evaluation on all individuals admitted to the County jail, provides the courts with sufficient information and recommendations for possible release on recognizance pending resolution of the case in court, helps relieve overcrowding in the jail, and allows the jail to operate with a simplified classification system, and

IV. WHEREAS, this program is 31% state funded and 69% locally funded, and

V. WHEREAS, sufficient funds are included in the budget to cover the cost of the aforementioned services, now, therefore, be it

I. RESOLVED, that the Chair of the Legislature be, and hereby is, authorized and directed to execute a contract, on behalf of Cattaraugus County, with the New York State Division of Criminal Justice Services, for the provision of the above-described program, for a term commencing July 1, 2023 and terminating June 30, 2024, according to the above-described terms, and be it further

II. RESOLVED, that upon termination of either state or federal funding for this program, then this program shall be automatically abolished, and be it further

III. RESOLVED, that such contract shall provide that upon the reduction of any such funding, the County, in its sole discretion, may terminate the contract on thirty (30) days' written notice, and be it further

IV. RESOLVED, that in the event of any such reduction, the department head involved shall immediately report such occurrence to the Chairman of the Committee to which the department is assigned, who shall add the matter to the agenda of the Committee's next meeting.
