**PUBLIC HEARING:**

WHEREAS, the proposal grants a 70% reduction of the assessed value on eligible land under the Forest Certification Program and a 40% reduction of the assessed value on eligible land under the Forest Management Practice Plan, and

WHEREAS, the Governor's proposal severely lowers the qualifications for an approved forest stand and has the potential to dramatically reduce the taxable value of local taxing jurisdictions, and

WHEREAS, local municipalities should be reimbursed for the full loss of the tax base, not the proposed above 1%, and

WHEREAS, the proposal includes the provision that the annual certification of the commitment to continued forest crop production will no longer be made to the Department of Environmental Conservation but instead will be filed with the local assessor, representing a shift in statutory duties that constitutes an unfunded mandate, and

WHEREAS, this proposal should be a local option to municipalities, now, therefore, be it

WHEREAS, fracking threatens potable water and there are documented cases of drinking water contamination that have resulted from spills of fracking fluid and fracking wastewater, including the discharge of fracking waste into rivers and streams, and the underground migration of fracking chemicals, including gas, into drinking water wells, and

WHEREAS, wastewater, wastewater solids or sludge, drill cuttings and/or other byproducts from the fracking process are known to contain toxic levels of contaminants, which are known to have health impacts, and

WHEREAS, in 2016, the United States Environmental Protection Agency (USEPA) issued pretreatment standards, contained in 40 CFR Part 435, which prohibit discharges of wastewater pollutants from onshore unconventional oil and gas extraction facilities to publicly owned treatment works, and

WHEREAS, the County of Cattaraugus values its lakes, rivers and streams, which provide habitat to a vast array of wildlife that depend on a healthy and clean environment, and

WHEREAS, the County promotes recreational use of the Allegheny River as a tourist destination and has invested in boat launches for access to the river for kayaking, canoeing and sport fishing, and

WHEREAS, the Seneca Nation of Indians is calling on the Pennsylvania Department of Environmental Protection (PADEC) to reject permit applications for the transport, treatment and release of thousands of gallons of dangerous wastewater generated through hydraulic fracturing processes into the Allegheny River, and

WHEREAS, the U.S. Army Corps of Engineers, U.S. Department of the Interior, Pennsylvania Fish & Boat Commission, New York State Department of Environmental Conservation and several independent scientists, who have submitted official comments to the PADEP, have already shared concerns, now, therefore, be it

RESOLVED, that the Cattaraugus County Legislature hereby supports a prohibition on the discharge of pollutants and dangerous fracking wastewater into the Allegheny River, and be it further

RESOLVED, that the Cattaraugus County Legislature hereby strongly urges the Pennsylvania Department of Environmental Protection NOT to issue a discharge permit to Epiphany Allegany, LLC's project in Coudersport, Pennsylvania, until such time as studies conclusively indicate that there are no contaminants in the discharge, and be it further

RESOLVED, that Cattaraugus County urges its Congressional and State representatives to intercede with EPA and request that EPA report to them on their response and adaptations regarding the aforementioned concerns, and be it further
