WHEREAS, this program is 39% state funded and 61% locally funded, and

WHEREAS, sufficient funds are included in the budget to cover the cost of the aforementioned program, now, therefore, be it

RESOLVED, that the Chair of the Legislature be, and hereby is, authorized and directed to execute a contract, on behalf of Cattaraugus County, with the New York State Office of Probation and Correctional Alternatives, for the provision of the above-described program, for a term commencing July 1, 2018 and terminating June 30, 2019, according to the above-described terms, and be it further

BE IT ENACTED by the County Legislature of the County of Cattaraugus as follows:

<u>SECTION 1.</u> Preamble. By Local Law No. 3-1989, as amended, the Cattaraugus County Legislature, effective January 1, 1990, established a plan of self-insurance provided for in Article 5 of the Workers' Compensation Law known as the "Cattaraugus County Self-Insurance Plan".

SECTION 2. Amendment of Local Law No. 3-1989.

Section 11 of Local Law No. 3-1989 entitled "A Local Law to Establish the Cattaraugus County Self-Insurance Plan and to Provide for the Administration Thereof", adopted by the Cattaraugus County Legislature on August 23, 1989, is hereby amended as follows: Delete "Six Hundred and Fifty Thousand (\$650,000.00)" and replace with: "Three Million (\$3,000,000.00)".

<u>SECTION 3.</u> Severability. If any clause, sentence, paragraph, subdivision, section or part of this local law or the application thereof to any person, individual, corporation, firm, partnership, entity or circumstance shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, effect or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, section or part of this law or in its application to the person, individual corporation, firm, partnership, entity or circumstance directly involved in the controversy in which such order or judgment shall be rendered.

SECTION 4. Effective Date. This Local Law shall become effective immediately.
