WHEREAS, the Sheriff's Office is desirous of applying for funding through OMH for The CARES UP Initiative Program, and

WHEREAS, the aforementioned Program is 100% state funded, now, therefore, be it

RESOLVED, that the Chair of the Legislature be, and hereby is, authorized and directed to execute grant documents, on behalf of Cattaraugus County, with the New York State Office of Mental Health in order to apply for The CARES UP Initiative Program funding, according to the above-described terms, and be it further

WHEREAS, on January 19, 2023, Russell Ulmer was accused of animal cruelty, and

WHEREAS, following an investigation and jury trial, Russell Ulmer was convicted of 38 counts of failure to provide proper sustenance and two counts of improper disposal of dead animals, and

WHEREAS, pending the outcome of the trial, the County was forced to seize the animals and provide them with food and shelter, and

WHEREAS, additionally, many County employees worked several hours to coordinate care, pay invoices, complete paperwork, testify at trial, and respond to the incident, and

WHEREAS, Cattaraugus County and its taxpayers should be reimbursed for the expenses involved with caring for these animals due to their owner's cruelty and neglect, which resulted in an economic loss of \$46,167.73, now, therefore, be it

RESOLVED, the Cattaraugus County Legislature does hereby approve the submission of the Probation Department's victim impact statement to be included with the pre-sentence investigation report seeking restitution from the Court, and be it further

RESOLVED, that the Clerk of the Legislature is hereby directed to send a certified copy of this resolution to the Cattaraugus County Probation Department.

BID ACCEPTANCE AND AUTHORIZING THE CHAIR TO EXECUTE CONTRACT FOR SALE OF TIMBER (Farmersville/Lyndon Ash Timber Sale - Towns of Farmersville and Lyndon)

Pursuant to Sections 219 and 450 of the County Law.

WHEREAS, the Clerk of the Legislature was authorized to advertise for sealed bids for the sale of ash timber from Cattaraugus County Farmersville Hardwoods Timber Tract No. 27, located off Route 98 in the Town of Farmersville, and Cattaraugus County Lyndon Hardwoods Timber Tract No. 9, located off Livingston Road in the Town of Lyndon, according to specifications provided by Generations Forestry, and

WHEREAS, the highest bid received meeting specifications for the sale of marked timber from the aforementioned property was the bid of Wagner Hardwoods, LLC, PO Box 68, Cayuta, New York 14824, in the amount of \$107,887.00, and

WHEREAS, Wagner Hardwoods, LLC, shall pay to the County 100% of the bid price upon signing of the Timber Sale contract, and

WHEREAS, Generations Forestry, the County's Forest Manager, has indicated that the price offered is fair and reasonable and should therefore be accepted, and

WHEREAS, Wagner Hardwoods, LLC, will complete the harvest and cleanup/restoration of the property by October 31, 2025, now, therefore, be it

RESOLVED, that the bid of Wagner Hardwoods, LLC, be, and the same hereby is, accepted, and be it further

RESOLVED, that the Chair of the Legislature be, and hereby is, authorized and directed to execute a contract, on behalf of Cattaraugus County, with Wagner Hardwoods, LLC, for the above-described sale of timber.

AUTHORIZING THE CHAIR TO EXECUTE SUPPLEMENTAL MEDICAID UPPER PAYMENT LIMIT SCHEDULE REQUEST FOR DEPARTMENT OF NURSING HOMES SUPPLEMENTAL FUNDING

Pursuant to Section 2808(12)(e-1) of the Public Health Law.

WHEREAS, the New York State Public Health Law provides for Supplemental Medicaid Upper Payment Limit payments of up to \$500 million statewide to non-state operated public nursing facilities, and

WHEREAS, the federal Centers for Medicare and Medicaid Services (CMS) have approved State Plan amendments to implement this supplemental payment provision in the amount of \$184,465,930.00 attributable to April 1, 2022 – March 31, 2023, and

WHEREAS, this \$184 million has been allocated to each qualifying nursing home based upon the ratio of each facility's reported Medicaid days divided by the total reported Medicaid days for all eligible public nursing homes for the 2020 calendar year, and

WHEREAS, the County's The Pines Healthcare and Rehabilitation Centers are eligible for payments of \$3,339,472.00 for the Olean facility and \$3,386,770.00 for the Machias facility, and

WHEREAS, since these payments are exempt from the Medicaid local share cap statute, counties in New York State are responsible for transferring the full 43.8% non-federal share of each payment to the State prior to the corresponding 100% payment being released to the nursing homes, and

WHEREAS, Cattaraugus County is responsible for contributing an Intergovernmental Transfer of the full non-federal share of the nursing home Upper Payment Limit in the amount of \$2,946,094.00 in 2023, and

WHEREAS, upon the State's receipt of the County's local share, a payment of \$6,726,242.00 will be made to the County in 2023, now, therefore, be it

RESOLVED, that the Chair of the Legislature be, and hereby is, authorized and directed to execute the Supplemental Medicaid Upper Payment Limit Schedule Request Form for the County Department of Nursing Homes as described above.
