### AUTHORIZING THE CHAIR TO EXECUTE CONTRACT EXTENSION WITH CONSTELLATION NEWENERGY, INC. FOR PARTICIPATION IN ENERGY PURCHASE PROGRAM

Pursuant to Sections 215 and 450 of the County Law.

WHEREAS, Act 476-2006, as amended by Acts 607-2009, 231-2015, 237-2016 and 354-2020, authorized the County to be a member of the Municipal Electric and Gas Alliance (MEGA), for participation in an energy purchase program, and

WHEREAS, Municipal Electric and Gas Alliance (MEGA), P.O. Box 88, Ithaca, New York 14851-0088, acts as an aggregator of power usage at no cost to the County, and

WHEREAS, MEGA has an agreement with Constellation NewEnergy, Inc., which allows the County to take advantage of the low market rate of \$0.07245/kWh until November 6, 2026, and

WHEREAS, a contract extension is necessary with Constellation NewEnergy, Inc., in order to lock in at the lowest market rates available for the period October 30, 2023 through November 6, 2026, now, therefore, be it

RESOLVED, that the Chair of the Legislature be, and hereby is, authorized and directed to execute a contract extension, on behalf of Cattaraugus County, with Constellation NewEnergy, Inc., in order to lock in the lowest market rates in the above-described energy purchase program, for a term commencing October 30, 2023 and terminating November 6, 2026, according to the above-described terms.
