**Details of Incident:** 

ON 2/2/2019 BRANDON M. BLACKSHEAR OF OLEAN WAS ARRESTED FOR CRIMINAL POSSESSION OF A CONTROLLED SUBSTANCE 5TH, AGGRAVATED UNLICENSED OPERATION 1ST (FELONY), RECKLESS DRIVING, RESISITING ARREST, DRIVING WHILE ABILITY IMPARIED BY DRUGS, UNLAWFUL FLEEING A POLICE OFFICER, MULTIPLE VEHICLE AND TRAFFIC VIOLATIONS, AS WELL AS A PAROLE VIOLATION. SALAMANCA POLICE DEPARTMENT ATTEMPTED TO MAKE A STOP ON A WHITE 4 DOOR SEDAN; AT THAT TIME MR. BLACKSHEAR FLED FROM SALAMANCA POLICE ONTO INTERSTATE 86 AND OUT OF THE CITY OF SALAMANCA. SHERIFF'S DEPUTIES ASSISTED AND TOOK OVER THE PURSUIT ONCE OUTSIDE THE CITY LIMITS. MR. BLACKSHEAR THEN FLED DEPUTIES EASTBOUND ACROSS INTERSTATE 86 AT HIGH RATES OF SPEED. MR. BLACKSHEAR EXITED THE INTERSTATE OFF EXIT 26 AND ONTO ROUTE 16 TOWARDS THE CITY OF OLEAN. MR. BLACKSHERTHEN FLED THROUGH THE CITY OF OLEAN UNTIL SHERIFF'S DEPUTIES WITH THE ASSISTANCE OF OLEAN POLICE DEPARTMENT WERE ABLE TO GET THE VECHICLE STOPPED AT WHICH TIME MR. BLACKSHEAR FLED ON FOOT. AFTER A SHORT FOOT PURSUIT MR. BLACKSHEAR WAS TAKEN INTO CUSTODY. MR. BLACKSHEAR WAS REMANDED TO CATTARAUGUS COUNTY JAIL ON NO BAIL, AND IS DUE IN SEVERAL COURT JURISDICTIONS AT A LATER DATE.
