Sheriff Timothy S. Whitcomb reports the following incident:

Details of Incident:

On 02/17/2019 at 6:58pm Lana K Watt, 50 of 1699 Quaker Run Rd was taken into custody following a traffic stop on Route 394 in the Town of Coldspring. The arrest stems from patrol observing Ms. Watt in the oncoming lane of traffic almost striking the patrol vehicle head on. Patrol had to come to a stop and leave the roadway to avoid a collision. Ms. Watt became combative while being taken into custody and refused to provide identifying information. She was taken to the Sheriff's Office for processing where she refused to submit to a breath test. Further investigation revealed her license was revoked for failure to comply with NYS drinking driver program. She was charged with DWI, AUO 1st, failure to maintain lane, failure to keep right, resisting arrest, and obstructing governmental administration 2nd. She was processed and released to a 3rd party.
