**Sheriff Timothy S. Whitcomb reports the following incident:**

**Type of Incident:** Assault on a Police Officer

### **Details of Incident:**

On 4/3/19 at about 02:30 am Kiersten K. Kennedy 24, from Lawtons NY was arrested for Driving While Intoxicated, Aggravated Driving While Intoxicatd having a BAC of .18 or more, Moving from lane unsafely, and Assault in the Second degree, after Sheriff's patrols responded to a Motor Vehicle Accident on State Rt 417 in the Town of Allegany. A roadside sobriety investigation deteremind that Ms. Kennedy was intoxicated. Ms. Kennedy was then transported to Allegany Police station to be processed for the Driving While Intoxicated Charge. At Some Point during the transport to the station, Ms. Kennedy had removed the hand cuff restraints ~~off~~<sup>on</sup>, and wrapped them around her hand. Ms Kennedy then struck a deputy in the face with them. After a struggle with the deputy Ms. Kennedy was placed back in custody. The injured deputy was transported by Allegany EMS to Olean General Hospital, and treated for lacerations to the face. Ms. Kennedy was arraigned in Allegany Town court and sent to Cattaraugus County Jail on \$25,000 bail or \$50,000 bond. The investigation is on going, and additional charges are pending.


